All entries along with the entry form and \$3 entry fee must be dropped off at the Youth Center on 20 Sanderson Street on Saturday, February 6th between 9:30AM- 10:00AM.

Construction

- Entries must consist entirely of LEGO, Duplo, Megablocks, or other LEGO-compatible plastic bricks and related pieces.
- Entries must be original creations, not based on LEGO-designed kits or instructions found online, in a magazine, etc.
- Entries must fit on a table or pedestal within a base area no larger than 10 x 10 inches.
- Gluing or otherwise affixing pieces to one another is permitted.

Age Groups

- Every entry will be judged in one of the following grade categories: Grades K-2, Grades 3-4, Grades 5-6

Prizes

- Prizes for creativity will be awarded in each of the 3 categories above.
- Judging will take place by a committee. Awards will be announced at the Beacon Field Awards Ceremony on Sunday, February 7th at 3:45pm.

All creations may be picked up at the Youth Center the week following Winter Carnival.
